Summary of Advocacy Committee Meeting August 9, 2012

1. Call to order

Judy Duncan, Chair, called the meeting to order at 1:15 pm EDT on August 9, 2012, in Washington, DC. Attendance is recorded in Attachment 1. Sharon Mertens was also present.

2. Highlights from Summer Meeting

Judy Duncan requested feedback on the Environmental Measurement Symposium. Comments included:

- The session on TNI updates for state accreditation programs seemed to be well-received.
- The Executive Officer of NACLA, Bob Uttenwieler, invited Steve Arms to repeat his presentation to a NACLA Board meeting in Florida this fall. The Advocacy Committee should also consider repeating the update session (or portions of it) as a webinar.
- As a follow up to the meeting with Dan Hautman, we should ask him if OW could put funds into our cooperative agreement for additional DW certification courses.
- Several expressed concern that the discussion about 3rd party ABs and the APHL position paper was embarrassing and inappropriate to have in front of Mr. Hautman.
- TNI needs to find a way to market small lab success stories better.

3. Position papers

Jerry advised the Advocacy Committee that the Policy Committee had reviewed our thoughts on position papers. The Policy Committee suggests that these papers be called "statements of belief" as opposed to position papers. The Policy Committee would also like for the Advocacy Committee to write the policy concerning development and approval of the "statements of belief".

4. Responses to Florida RFI

Jerry reported that there were 6 responses(including TNI's) to the Florida RFI concerning privatization of their lab accreditation program. There has been no action by the state as yet.

5. Methods Update Rule (MUR) RFP

Jerry reported that he had received two responses to TNI's RFP for training on the MUR. Each one included a multiple webinar format. In addition, TNI has developed a one hour overview webinar demonstrating how the TNI standard can

be used to comply with the essential QC elements of the MUR. Jerry requested feedback about how to coordinate the shorter one hour training with the multiple sessions training. Suggestions included offering the one hour training first for a \$25 fee to see if there is demand for additional in-depth training. The proposals received could also be turned into a live training and offered through state organizations or at a future TNI meeting.
