5. SOPs

1-109 Analyte Codes:

We didn't address the issue of ATPs and whether or not to mark them as approved. With a letter from EPA, Dan has marked them approved. Is this okay? Yes. What does he do if he doesn't have a letter? Then they are not approved. Dan can put them in, but not marked "approved."

EPA is no longer doing/providing letters. If a letter comes out, how does Dan get notification? There may be an email list to sign up for. Jerry will check and see if he can find out what is happening so Dan knows whether to mark them approved or when/how.

6. Website

William had reported previously that after the New Orleans conference he would add SSL encryption to the website so that Google Chrome would not start indicating the website is "not secure." That change was completed, and so now when you visit nelac-institute.org you will now be shown a "secure" version of the website, which looks just like the old "not secure" version, except it is now SSL-encrypted.

The 9-hour radiochemistry webcast training that was recorded in Albuquerque has been posted for purchase. The next radiochemistry webcast in the series was recorded in New Orleans and will be posted when available.

The last update to the Internal Audits program was completed two weeks ago and sent to Ilona; no comments received to date.
