Summary of Mentoring Subcommittee Meeting June 25, 2020

1. Call to order

Steve Arms called the meeting to order at 11:00 am CDT on June 25, 2020. Attendance is recorded in Attachment 1. Steve announced that Jacob would likely be back for the next call.

2. Minutes

Minutes of the May 28, 2020 meeting were reviewed. Mike Michaud moved approval. Harold Longbaugh seconded. All present voted in favor. Jerry Parr noted that William Daystrom had set up a page on the TNI website for the Mentoring Subcommittee to post documents and meeting minutes.

3. Questionnaire

Steve introduced the mentoring needs assessment questionnaire that Michael and Susie had worked on and thanked them for their efforts in putting this together. Members shared the following comments and suggestions on each section.

Part 1: Laboratory Information

- We should remove the laboratory's name and location from the front of the form and move to the end.
- Delete the section on past/current accreditations and certifications.
- We should also consider adding a confidentiality statement at the end also to say that it is not our intent to share any information on this form with regulatory authorities.
- Members agreed that the focus of the questionnaire was non-accredited and accredited labs.

Part 2: Questions

- Change the heading to "General Questions"
- Revise wording so that question don't start out "Does the laboratory have....." This might send the wrong signal. Suggested wording "If accredited, was it difficult to...." or similar.
- Add the word "current" to the appropriate questions.
- Add the question "Has the lab performed a gap analysis or internal audit to the TNI standard?"
- Suggested question "Have you reviewed documents within the last 1-2 years?"
- Suggested question "Does the laboratory have a process to create and retain clear records for employee capability and for data generated?".

Part 3: Questions for labs currently or previously certified or accredited

- Add "Detailed" before "Questions" in heading.
- Change format of section to check box. Check all boxes that you need help with.
- We should consider using survey monkey to collect information.
- Consider re-formatting to follow sections of the TNI standard.

• Delete question about the Safety SOP.

Additional suggestions:

- When this survey is posted or sent out, we will need to have introductory material. Language from the charter and Jacob's presentation would be good to use.
- Also, do we need a questionnaire for potential mentors to learn who is available for what types of skills? It was agreed that potential mentors could be both TNI and non-TNI members. Mentees will have to be members.
- Michael and Susie will take the first cut at re-formatting as discussed today. Jerry help with survey monkey. Note: Mary Johnson followed up after the meeting and volunteered to help with survey monkey also.
- We need to determine how to identify which labs will get the survey.
- We need to take some time to outline process before we get into the lab surveys.
