# NEFAP Executive Committee Meeting Summary February 17, 2012

#### 1. Roll call:

Chair Marlene Moore called the NEFAP Executive Committee meeting to order on Friday, February 17, 2012 at 11:00am EST. Attendance is included in Attachment A. There were 11 committee members present.

The minutes from the Sarasota meeting will be approved at the next meeting.

### 2. Evaluation SOP

Doug Leonard sent the following information regarding the update yesterday evening:

The first part is in Section 5. It defines the Recognition Council Members must be trained.

- 5.1 All evaluation team and recognition council members must meet minimum requirements for training and professional qualifications as defined in this Section.
- 5.2 The evaluators must successfully complete the appropriate NEFAP accreditation body evaluator-training course. The training course is in two parts:
  - Part 1: TNI FSMO standard additional requirements and
- Part 2: ISO/IEC 17011 requirements. All evaluators must complete Part 1 training from a TNI-recognized training course. If the evaluator has successfully completed ISO/IEC 17011 from an IAF/ILAC recognized training course this may be used for completion of Part 2 training. Recognition council members should complete Part 1 and/or Part 2 of the NEFAP evaluator training course.
- 5.3 All members of the evaluation team and recognition council members must sign the conflict of interest statement. See Appendix A for the Conflict of Interest form. All members of the recognition council should be informed when any member of the council declares a conflict of interest in regards to an AB evaluation report.

The second part is Section 6.11. It defines what is to be submitted to the Evaluation Council for review.

6.11 Recommendations to the NEFAP Recognition Council

6.11.1 All recommendations to the NEFAP Recognition Council regarding NEFAP recognition must be made in accordance with the TNI Standards. The LE shall be responsible for preparing the written recommendation with input from, and on behalf of, the entire evaluation team. Appendix E provides a model recommendation letter.

6.11.2 Copies of the evaluation team's document review report, the applicant's document review report corrective action response, evaluation team's on-site evaluation report including the witness assessment of the FSMO(s), and the applicant's on-site evaluation corrective action plan must be provided with the recommendation letter. The NEFAP Recognition Council must evaluate the information for consistency according to the evaluation SOP and the TNI standards. (<NEW PROPOSED 2/16/2012 by Doug L.> The recognition council shall make a decision based on the merits and completeness of the report.)

Our current Evaluation SOP has the entire EC voting and this is causing some issues for the ABs. The EC did a preliminary process in order to get the ABs in place to be able to receive applications. Tracy and Doug sent out a DRAFT of the Evaluation SOP update. They are suggesting a Recognition Council instead of the full vote of the EC. The recognition council would confirm that all processes in the evaluation have been complied with, the reports meet the requirements, and then they vote. Persons on the council need to be trained in order to do a good job. People need to have training on both Volume 1 and Volume 2 of the Field standard. Doug emphasized that he would want to see balance on the Council.

All the documentation of the training of members of the "Recognition Council" will be reviewed. Is the council's primary role to look for bias and completion? The EC discussed the real need for specific ISO 17011 training.

Keith provided the following comment by e-mail on 2/17/12:

The council or by whatever name you give it should not be reviewing the reports for technical rigor. They can review for any signs of bias but the AB either meets the requirements of the evaluation procedure as evident by the evaluation teams report and any subsequent closure of non-conformances with effective corrective action taken by the AB.

The members on the call are leaning towards more of a bias and completeness review.

Mike noted that he would like to see the committee also look for consistencies between ABs. This has been an issue in the past for NELAP. Randy commented that the training, conference calls and tools are helping with the consistency. He also suggested that the recommendation should be done by the Recognition Council instead of the Lead Evaluator. The Evaluation Team should just be fact finders.

Tracy does not see any problem with the Lead Evaluator making a recommendation. It was also commented that the lead has a closer relationship with the AB and it makes more sense for them to make the recommendation. Marlene noted that there could be anti-trust issues because the Lead Evaluators do generally work for one of the ABs.

The thought is that the EC would appoint the representatives to the Recognition Council. If this is the case, a procedure for doing this needs to be developed. Doug did not think they had to be members of the EC to be on the council. They would likely need to be TNI members.

Marlene asked if anyone had objection to a Recognition Council. Tracy expressed the concern that the people on the council need to know the process and how ABs operate. EC members would be voting to develop the make-up of the Council.

Marlene would prefer that the rotation for Council members be 4 years so that the same people would be involved in the approval of all ABs being approved through a cycle. She would not want to see different ABs approved by different councils. Doug L. recommended a separate SOP for the Council.

Doug L. will work on a document to define the Recognition Council for the next meeting. Tracy will update the Evaluation SOP.

Marlene expressed some concerns about how ABs are assessing FSMOs. She wants to ensure that what is in the FSMO standard is being used and not what is in the NELAP standard. Technical evaluators will be sent into the field. Marlene, Lead Evaluator and Coordinator will be selecting the Technical Evaluator. Marlene would like to make sure that all the Technical Evaluators have the training and that a conference call be set-up with the group to ensure everyone is on the same page.

- There is quite a bit of training going up for NEFAP Assessors. There will be training March 19-21<sup>st</sup> in Chicago. More of the focus will be on the air side. Other courses will be in May and June. There is also training that may occur at NEMC.

- Get Bios in to Ilona. Should be in paragraph format.
