Discussed the language needed to instruct labs how to report non-detected results. It was determined that the language belonged in section 5.1.3. The language will direct labs to report down to their lowest calibration value and to report a less than if lower than this.

Curtis will revise Volume 3 such that any reported value of "<x" will be acceptable if the lower PT acceptance limit is less than x.
