Agenda Item 1: LASC Comment Review

The call attendees reviewed and discussed each of the remaining items on the LASC Report for V1-V4 and devised a proposed repsonse. Kirstin will summarize the response and forward to each committee member for approval prior to submission of the response to the LASC.

In the discussion of a comment from the LASC for a clause included in V3 regarding the composition of PT samples used for corrective action, the call attendees agreed that the composition of a corrective action PT should be unknown to the laboratory because proficiency includes the ability to identify and correctly not identify analytes present in an environmental sample. The PT samples should be handled in the same manner. However, it is unknown if a change such as this could be proposed at this time with an interim amendment. If so, the call attendees recommend a change to the standard. If not, the recommendation should be held for future revision. Kirstin will check on the requirements regarding interim amendments.

Agenda Item 2: LASC Request for Interpretation

Dan Tholen provided some perspective on some of the items listed in the latest request for interpretation. These items were sent to the PT Board with input requested by the committee. The call attendees decided the best way to handle this would be for each member to review the request and provide input to Kirstin. Kirstin will consolidate the comments from each member for further discussion by the committee.

Agenda Item 3: Assessor Forum

Matt will provide 1 hour presentation at the Assessor Forum in Miami. The topic is a cross-walk between the 2003 NELAC PT Standard to the TNI PT Standard. Matt intends to cover the major changes such as PTRL to LOQ reporting of PT samples.
