The Committee had two outstanding SIRs to be considered (SIR 266 and SIR 275). Shawn asked the members to read them and to be prepared to discuss and vote on them during the next meeting.

Shawn would send out the final versions of Volumes 3 and 4 and the response-to-comments spreadsheet to Ken for publication on the TNI website and notification to the commenters of the disposition of their comments. The committee would meet again in 2 weeks to discuss the SIRs and Shawn's upcoming presentation at the Environmental Measurement Symposium in Orange County, CA.
