"Summary points agreed to by the TNI Board:

• Consensus not to have multiple standards – same QS system for all

- Documentation appropriate to scope of lab rather than one size fits all
- Same for management requirements
- Look at scope/function/complexity of the lab rather than size Bring these groups to the table – need to talk about in detail"

Premise: All laboratories should be held to the same QS standard. The standard needs to provide flexibility to allow implementation by laboratories with different scopes, functions, complexities, and environmental programs.

Preliminary work on the project will begin April 19 at 11:30 CT. A paper will be outlined by Ken, Bob, Jim, Andy, Judy, Jerry, and Aurora:

Problem statement - frame the issue. Develop the process. Identify the stakeholders. Plan a Meeting to get the work done. Identify the base/minimum requirements. Identify implementation needs and tools. If a new standard is needed, how do we present it to the standard development program for development?
