Summary of Advocacy Committee Meeting January 7, 2021

1. Call to order

Steve Arms called the meeting to order at 12:00 Noon CDT, January 7, 2021. Attendance is recorded in Attachment 1.

2. Approval of Minutes

Minutes from November 5, 2020, and December 3, 2020, were reviewed. Martina moved approval and Sharon seconded. All present voted in favor.

3. Review of the Mentoring Subcommittee PowerPoint for virtual winter conference

Jacob Oaxaca, chair of the mentoring subcommittee, joined the call to review the PowerPoint presentation prepared for the virtual winter conference. He asked for questions and input from the Advocacy committee. Questions and comments Included:

- Are we mentoring the lab or an individual? Ans: We are mentoring the lab, but there is one contact person.
- Add a bullet saying that at least one member of the lab being mentored should be a member of TNI.
- Make sure we emphasize that mentoring is focused on the implementation of a quality management system and not necessarily on acquiring accreditation. Add a sub-bullet to slide #2.
- Add a bullet about mentor sign up. Will we vet mentors? Ans: We are not planning to, but mentors could be asked to submit qualifications. We will also need to add a disclaimer about mentor qualifications and abilities.
- Could we require that a mentor is from a lab accredited for the program being mentored? Ans: No, that might exclude too many mentors.
- How long does the mentoring relationship last? Ans: Until either party withdraws.
- How does a lab transition from a mentoring to a consulting contract? Jerry will work with Jacob and Lee to define that.

4. Winter Virtual Conference

Jerry summarized the four special sessions of the conference and indicated that he still needed two additional speakers. Robin agreed to speak on the How Accreditation Improves Laboratory Data Quality and Performance panel. Jerry will talk to Paul Junio about speaking on the Improvements in Laboratory Performance and Data Quality panel.

Steve reviewed Friday morning's Advocacy meeting and noted that the member spotlight for the next newsletter will likely be Dave Speis since he will be completely retired soon. He also noted that the annual report which will highlight Advocacy's plans and accomplishments will be presented at the Monday morning plenary session. A decision about the February Advocacy meeting will be made at the Friday meeting.
