# Summary of Advocacy Committee Meeting January 6, 2022 1:00 pm Eastern

#### 1. Call to Order

Steve Arms called the meeting to order at 1:00 pm Eastern, January 6, 2022. Attendance is recorded in Attachment 1.

## 2. Approval of Minutes

Minutes from December 2, 2021 were reviewed. Robin moved and William seconded that the minutes be accepted as presented. Approval was unanimous.

### 3. Updates

Value of PT Initiative – this will be a long-term project and only updated when progress occurs

### 4. Advocacy Representative Requested for Policy Committee

Policy Committee sometimes struggles to attain a quorum for its twice monthly meetings, and would like to add another member to help with this. They requested someone from Advocacy specifically and William Lipps agreed to take this on. Thank you, sir!

5. FDA Rule Requiring Accreditation for Bottled Water and Water for Agricultural/Food Processing Use

From the December Board meeting, Jerry explained that a new final rule from FDA will require laboratory accreditation for the analysis of foods, to include bottled water as well as source water for agricultural and food processing uses. [See the announcement by FDA at <a href="https://www.fda.gov/food/cfsan-constituent-updates/fda-issues-final-rule-laboratory-accreditation-analyses-foods">https://www.fda.gov/food/cfsan-constituent-updates/fda-issues-final-rule-laboratory-accreditation-analyses-foods</a>.] As written, accreditation could only be by an AB recognized by an ILAC signatory. Jerry plans to write to FDA asking that NELAP accreditation be accepted for the water

uses only, as several states already require testing by NELAP-accredited labs, and he will ask Advocacy to review that letter.

UPDATE: The January Board meeting (January 12) discussed this further, and after initially thinking that the rule applied only in outbreak situations (so, no exception needed), it turned out to be more complicated, after all. Jerry and Patsy Root will seek to have a conversation with the identified contacts for this proposed rule

#### 6. Review of Workplan

Steve led a discussion of the remaining high priority item, which concerns TNI membership:

Create and sustain a systematic approach for encouraging volunteers to become involved in TNI activities and ensure a pool of volunteers is available for all types of committees. (Goal 2.1)

A number of ideas were mentioned in what became a brief brainstorming session, and those are captured below. Steve noted that it may not be possible to "ensure a pool of volunteers", simply because of the nature of our work. There were no ideas offered that appear to support a systematic encouragement for volunteers, however, and the path to fulfilling this goal remains unclear. Currently, individuals are recruited by colleagues when a need is recognized, and those members who do volunteer to serve on committees are quickly contacted about vacant slots or offered associate membership if no suitable vacancy is open at the time they apply.

- A periodic email or special mailing
- A quarterly summary of committee openings and a time for an "information session" to discuss what each committee does (teleconference)
- Mention involvement with any activity
- An awards ceremony for volunteers
- Have membership information available at the information booth for NEMC meetings
- Hold a welcome reception for new members
- Hold a short session at every conference for first-time attendees
- Promote the benefits of committee membership "Form Your Future"
- Expand recruitment beyond TNI conferences
