6. Letter from ELAB to the FEM

Jerry advised the committee that after discussion with Sharon Mertens and TNI staff, he had decided to recommend to the Board that TNI not directly respond to the ELAB letter. Instead, he will recommend that TNI provide the FEM with a progress report on TNI accomplishments since we last briefed them. This will be on the agenda for discussion at the next Board meeting. Jerry anticipates that the Advocacy Committee will be involved in drafting the response if the Board concurs. Lara noted that the FEM will likely respond to ELAB before their February 20 meeting.

7. Session in San Antonio for Data Users

Jerry reviewed the concept discussed in Denver for a half day session for data users and the benefits of using accredited FMSOs. Jerry indicated that he hoped the session could also be used as a webinar for those who cannot attend. Jerry requested input on his suggested list of topics and ideas for speakers. This item will be on the agenda at the next meeting.
