Summary of Advocacy Committee Meeting May 1, 2014

1. Call to order

2. Approval of minutes

Minutes of the April 3, 2014, meeting were reviewed. Elizabeth Turner moved approval, and Janice Willey seconded. All present voted in favor.

3. WE&T articles for WEF

Elizabeth Turner reminded everyone that TNI committed to providing 2 articles per year on laboratory topics to WEF's WE&T Journal. An article is needed by June 2. After discussion, the committee agreed that an article on MDLs would be good later in the fall. Other topics mentioned were the He shortage and NEFAP. Elizabeth will pursue the He article. Carol will contact JoAnn Boyd to see if she can provide a NEFAP article. Steve suggested that we have a standing agenda item for article suggestions.

Note: JoAnn Boyd agreed to provide a NEFAP article by June 2.

4. Update on Future Planning Project

Carol reported that 38 non-NELAP state programs had been contacted. Twenty one states have been or are scheduled for interviews. Two states declined. There was no response from the others. Georgia was one of the states that did not respond. Members agreed that GA should be contacted again and Judy Morgan provided an alternate contact name. Carol will begin summarizing interview results so that we can factor that into the next steps. The next step is to plan webinars to get input from other stakeholders.

5. Newsletter

Jerry suggested that the target publication date for the next newsletter should be July 1, with the understanding that it won't actually go out until after July 4th for maximum readership. Lynn Bradley will be the editor and article due date is June 15.
