1. Call to order

5. Exploring the Future of National Environmental Laboratory Accreditation – Friday workshop

- Would your laboratory use a third party accreditor?
- Do you prefer accreditation to ISO 17025 over the TNI standards?
- Is there anything that the TNI standards should cover that is not already covered?

7. Laboratory Practices Handbook

Lynn Bradley developed a draft proposal for developing guidance that will need to be approved by the Policy Committee to cover the handbook development. The draft proposal was approved by acclamation and will be sent on the Policy Committee.

Elizabeth brought up the issue of sample collection and internal sample handling and asked how the committee thought these should be approached, either in one chapter or separately. Elizabeth will discuss this will Rebecca Pierrot who is drafting the sample handling chapter.

The next step will be to merge the outlines received so far and let the editors review to see if it makes sense, and that everything we intended is covered.
