# NEFAP Executive Committee (NEFAP EC) / Field Activities Committee (FAC) Meeting Summary January 23, 2018

#### 1. Roll call:

Kirstin Diagle, NEFAP EC Committee Vice-Chair, and Kevin Holbrooks, FAC Chair, called the NEFAP Executive Committee and FAC meeting to order on January 23, 2018 in Alburqueque, NM at 3:30pm Central. Attendance is included in Attachment A - there were 5 NEFAP EC committee members present and 2 by phone. There were 2 FAC members present.

#### 2. FAC Business (Facilitated by Kevin)

2014 TNI Field Standard Review and ISO/IEC 17025 Update:

#### Comments:

- Carl noted that ISO/IEC 17025 is applicable to the TNI Field Standard. Sampling is performed where subsequent testing will be involved.
- The Standard could add Modules for specific types of testing or technologies. This would allow more specific requirements to be included in the Standard.
- It was asked if the Standard needs to be made more flexible to other media?
- Is there a conflict between NELAP and NEFAP with the additional information included in the Sampling section in the new ISO/IEC 17025:2017? The committee needs to spend time understanding what the issues are.
- A joint meeting should be planned with QS and LASEC.
- Kevin (Chair, FAC) will begin attending NEFAP EC meetings so the committees can work closely as the Standard is updated.
- There could be a Demonstration of Capability (DOC) approach in sampling. There should be documentation of the ability to sample according to the method or SOP.
- The guidance on Scope of Accreditation is still under review in the FAC. It is a higher level view compared to NELAP. Once the FAC completes its review it will be shared with the Policy committee.

• Paul would like to see a more detailed FSMO scope of accreditation to facilitate recognition by state-based accreditation bodies (ABs).

#### 3. NEFAP EC Business (Facilitated by Kirstin)

- The committee is accepting nominations for committee membership. It will hold an election in March. There will be 3 FSMOs and 2 Others rotating off. The new members will begin work in April 2018. New committee members can be from the same organization a current rotating off member is from.
- Paul and Kirstin will begin reaching out to potential Task Force members in February.
- The NEFAP EC will begin reviewing the last version of the NEFAP Marketing/Strategic Plan and updating it as needed. Justin and Shawn will be working with the NEFAP Marketing/Strategic Planning Subcommittee. One topic of discussion will be exploring the possibility of NEFAP expanding beyond environmental. Another topic will be preparing a document comparing ISO/IEC 17025 accreditation verses the TNI Field Standard.
- The committee began work on the NEFAP Evaluation SOP. The committee plans to review this SOP to determine whether a Program Evaluation/Recognition SOP is needed or if the combined Evaluation SOP can stand alone and be used.
  - Scott Hoatson questioned the need for the Recognition Committee or is this another layer of bureaucracy? The differences between the Governmental AB and Non-Governmental AB needs was reviewed to answer this question.
  - Comments While Reviewing Current Program Evaluation SOP:
    - Section 1 Remove last paragraph.
    - Section 2 Delete wording. Review after the SOP is done and include only information that is left in the SOP.
    - Section 3 Review once other sections are complete.
    - Section 4 Review once other sections are complete.
    - o Section 5 Delete. Refer to SOP 7-101 (Combined Evaluation SOP)
    - Section 6 Delete 6.1 6.10. Refer to SOP 7-101. Section 6. 11 could discuss recognition process once the recommendation is submitted to the NEFAP EC. It would include issuance of the certificate of recognition. The recognition committee has reviewed that the evaluation team has followed procedure and the EC is reviewing whether the RC has followed procedure and whether they accept or reject the decision.
  - Kirstin will continue to review the SOP and propose an update at the next NEFAP EC meeting.
