Field Activities Committee (FAC) Meeting Summary

October 18, 2013

1. Roll call and Minutes:

Chair, Justin Brown called the FAC meeting to order on October 18, 2013 at 11 am EST. Attendance is recorded in Attachment A – there were 8 members present. Associate members present: Mike Miller, Kevin Holbrooks, Terrance Romaine, Craig Sprinkle and Rich Smith.

The minutes did not make it to all members of the committee, so the 7/29/13 and 8/8/13 minutes will be distributed by e-mail to all committee members for their review and confirmation

2. Further Discussion on Standards

The interim standard has been sent to the Standards Review Council. Since this Council has not been formed yet, the CSDP EC will be doing the review as a complete committee. This group is made up of the chairs of all the Expert Committees. They will be looking for grammar, formatting and consistency with other modules of the standard. Justin thinks the only possible concern might be with definitions, but the FAC did try to make definitions consistent.

The CSDP set a date of November 11th for the committee to complete their review. Any recommended changes will then come to the FAC. The FAC will need to re-vote before the standard is finalized. If there are no changes, the standard is final.

Justin's goal is to have the standard finalized by the Kentucky meeting.

3. Charter

Mission:

Language is needed to make it clear that the FAC works closely with the NEFAP EC. Perhaps it would help to add language such as: The FAC supports the efforts of the NEFAP EC in providing guidance materials etc

Mike noted that it is not clear that there is a standard for ABs and a separate one for FSMOs.

Suggested Language Change:

The mission of the TNI Field Activities Committee is to develop specific field accreditation standards for accrediting bodies and FSMOs. This is accomplished by engaging industry experts in a consensus-based standards development process providing the means to improve the quality and consistency of environmental data throughout the United States.

After further discussion on the roles of FAC and the NEFAP EC, the following language changes are suggested:

The committee supports the efforts of the NEFAP EC to implement these standards by developing guidance materials to facilitate implementation and adoption of these standards on a national and international level. This is accomplished by working with the National Environmental Field Activities Program (NEFAP). The committee is committed to establishing and maintaining an environment for standards development that will ensure continual improvement of field accreditation standards that are aligned with the practical constraints of sampling and field measurement as well as regulatory and industry specific requirements. (Language about SIRs needs to be added.)

Justin and Ilona will further work on the language and distribute it for review to the committee.

Strategic Goals and Objectives:

The following changes were recommended:

- 2. Engage industry-experts in the standards development process through targeted outreach activities to ensure the development of standards for various media that are practical, appropriate and implement-able for organizations of varying size and structure.
- 3. Last sentence is not needed. Don't need to specify field accreditation.
- 4. and 5. Delete. This is implementation.
- 6. Success measures need to be evaluated for the committee.
- 7. Emphasize support role of FAC.

Add a section regarding role with SIRs. Ilona will find the language being used in other committee charters.

Also add something about revising and improving the standards based on stakeholder comments and experience in implementation.

Justin will send a notice for everyone to provide comments by e-mail so the committee can try to finish this in November. Justin will send his comments to Ilona and she will make the changes to the Charter.

4. Membership

There are 4 members rotating off. We have been receiving nomination forms and it does not look like there will be any balance issues. The resumes will be distributed to the committee members before the next meeting and the committee will plan to vote in new members in November. Justin thanked Magie for her help in getting nominations.

5. New Business

- Brochure. Jerry has a final copy of the brochure and it is being printed.
- There is a Battelle Conference in May 2014 in Monterey, CA. Justin did not want to apply to speak until we could confirm we have a speaker that will be attending that meeting. It looks like we do, so Justin will ask JoAnn to submit an abstract.

7. Next Meeting

The next meeting will be planned by e-mail for mid November.
