3. Review Tracking Spreadsheet

Tracking spreadsheet was reviewed and updated. William and Dan will forward their updates to Jan. Jan will update the spreadsheet and send to John to be sent out with the agenda for the next meeting.

4. Reconciliation of LAMS Analyte Names with FoPT Tables (Maria)

Maria will send an example of what she's referring to via email (see email from Maria dated November 20). The issue is not so much with the analyte codes, but with the analyte names. Dan sat in on the AB Council meeting and they agreed that whatever we picked, they should be the same between LAMS and the FoPT tables. Whatever name is used in the EPA Method should be the name we use – we've tried to do this in the past.

Essentially, the PT committee should use the name that's in LAMS. If they don't like that name, we can work on that, but that's the one that the ABs are using and that's the one that ought to be used.

They will use the names as posted in LAMS. Any that have a discrepancy will need to be escalated to a different committee.

5. Website Update (William)

Completed VDS vote. Started accepting Board nominations. Posted new version of 2016 Standard. Replaced newsletter webpage with one that does not cut off listing of recent newsletters. Posted several recently finalized SOPs provided by Lynn and Ilona. Enrolled two new voters for Standard Interpretation Requests. Routine updates.

Internal Audits Database: Initial development completed. Now on hold pending receipt of completed audit checklists for testing.

6. LAMS/Method Compendium/GenApp

LAMS: When searching for labs by AB, search results used to include, besides labs with FOAs from the selected AB, labs that were primary for selected AB, but that had no FOAs from that AB (i.e., the lab had FOAs from other ABs, but not the primary AB). The query was changed so that search results will only show labs that have FOAs from the selected AB. Also added "Active" field to export CSV for lab demographics.

Link works for anyone now, but when the Method Repository goes live, it will be put behind a "paywall" (meaning you need to have a member login to TNI website to access the Method Repository). The issue reported at the last IT meeting regarding integration with aMember authentication has been resolved.

What sets the Method Repository apart from ordinary LAMS:

- a) Repository provides methods and analytes only.
- b) Repository method page includes column with direct links to method PDFs, when available.
- c) Repository method details page includes a summary of analytes associated with that method (according to FOAs).
- d) Repository analyte details page includes a summary of methods associated with that analyte (according to FOAs).
