# **Laboratory Accreditation System Executive Committee Meeting Minutes**

A flowchart for developing a standard was distributed to the committee (Attachment B) by the chair. Kirstin reviewed the process. Everyone needs to review the chart and be prepared to comment at the next meeting.

### 5) SIRs

Ilona will summarize the process in DC and provide information on number of SIRs, open SIRs, etc. The committee wants to look for ways the LAS EC can expedite the process.
