Laboratory Accreditation System Executive Committee Meeting Minutes

December 14, 2012

1) Roll call and Approval of Minutes

Kirstin Daigle called the TNI LAS EC meeting to order on December 14, 2012, at 1:35 pm Eastern time. The Committee agreed to meet on this date after the regularly scheduled December 5th meeting was cancelled. Attendance is recorded in Attachment A.

No further comments were received on either the November 7 minutes. The minutes are considered approved and will be forwarded to the webmaster for posting.

2) Announcements and Conference Session for LAS

Kirstin noted that the cut-off dates for the January conference in Denver -- early registration fees, as well as for the hotel room block – are approaching rapidly.

Kirstin then noted that she has accepted a new position, one where her workload will require her to take a break from TNI activities, and that she won't be able to attend conference in Denver. We discussed teleconferencing options for that meeting as well as having someone on-site to moderate the meeting even though Kirstin can be on the phone.

All agreed with Kirstin's suggestion that the full 3-hour session on Wednesday morning, January 16, should have focus on the changes to the SIR process and the Accreditation Council's (AC's) request that LAS develop a policy concerning changes to an AB's operations. If the Consensus Standards Development Executive Committee provides information on its development of standards review procedures, those will also be included on the agenda, since LAS will also need procedures for reviewing new standards (CSD EC meets the following day.)

Participants also agreed with the suggestion to actively recruit new LAS members at conference, since 7 of our 14 members have now served 2 3-year terms and are obligated to leave the LAS at the end of the conference. The TNI Board has been asked to identify a suitable individual to serve as chair following Kirstin's departure.

3) Standards Interpretation SOP

Kirstin had circulated another draft of the revised SIR SOP (3-105) and most of this meeting was devoted to discussing and editing that draft.

Kirstin will make the final changes as discussed and circulate the revision for comment, in hopes that an email vote can be completed prior to our next meeting at conference.

4) Pending Request from NELAP AC for Advice on Addressing Changes to AB Operations

In April 2012, the AC asked the LAS EC for consensus recommendations on how to address changes to an AB's operations that might require a full evaluation outside of the normal 3-year cycle. This arises from the possibility that one or more ABs may shift to

use of a contract accreditation body making recommendations for accreditation to the state. There was insufficient time remaining to take up this issue, but it will be addressed at conference. Participants requested that they be sent a link to the AC's web page so they can become familiar with evaluation procedures and AB operations in order to be knowledgeable about the relevant issues, prior to conference. The agenda will be the revised SIR SOP 3-105, the AC-requested recommendations for handling changes to an AB's operations, and possibly beginning discussion of the LAS's role in reviewing new standards, depending on CSD EC's progress.
