Laboratory Accreditation System Executive Committee Meeting Minutes March 25, 2014

1) Welcome and Roll Call

Frequently Asked Questions

Two of the FAQs were approved by consensus during the February meeting, from SIRs 53 and 71. Judy will use these as examples to discuss with the Chair of Policy Committee whether or not our FAQs must be considered "guidance."

Ann Marie had sent Judy a few edits for the remaining FAQs. These slight revisions will be shared with the committee, and an email voting process was suggested. David

moved and Kristin seconded to conduct an email vote to approve the FAQs after the meeting. This will allow for a 2-step approval process – first, to approve conducting an email vote and second, to conduct the actual vote on the FAQs.

Revisions to AC Standards Review and Acceptance SOP 3-103

Revisions to the Standards Development Review SOP 3-106

Although this document was approved with multiple edits at our February meeting, the promised "final" version including the not-yet-approved definitions for "modified interim standard" and "modified voting draft standard" are definitions that need to be added to the Consensus Development Standards Executive Committee (CSD EC) Standards Development SOP 2-100 was not circulated.

SOP 2-100 will remain in Provisional form due to the ANSI audit of TNI's consensus standards development process. The auditors have already, during preliminary reviews, indicated that revisions will be required. Still, the TNI Board asks that revisions to the LAS EC and AC versions of related SOPs continue towards final, so that a planning session during conference in DC, in August, will have final versions of the standards development, review and acceptance SOPs available. This session will be to plan for final approvals, review, adoption and eventual implementation of the full revisions of Volumes 1, 3 and 4 of the TNI Standard that will be completed in 2015. (Volume 2 is not undergoing revision at this time.)

Judy indicated that she wishes to send the current version of SOP 3-106 to Bob Wyeth, Chair of the CSD EC, for his review and feedback, and then will ask for LAS approval during the April 22 meeting.
