## Laboratory Accreditation System Executive Committee Meeting Minutes April 24, 2018 1:30 pm Eastern

#### 1) Welcome and Introductions

Judy Morgan welcomed everyone to the meeting. Attendance is recorded in Attachment A. Minutes from March 27, 2018, were approved by acclamation, in the absence of a quorum.

#### 2) Assessment Forum and Mentor Session Update

For the Assessment Forum, Judy, Silky and Harold met in early April, settling on a two-part program – the first part focused on changes to the standard and identifying aspects that can be implemented early, and the second part addressing both of the Chemistry guidance documents. Additional input and help are still invited for both sessions.

Dorothy provided a written update after the meeting. She has contacted Michelle Wade, Pam Schemmer, and Scott Siders to assist with the Mentor Session. They will develop a survey to be sent out to TNI members in regard to the "oh crap" moments in their labs using the TNI email list with Jerry's cooperation.

## 3) Chemistry Guidance

Since the March LASEC meeting, TNI's Policy Committee reviewed both the Calibration and the Detection & Quantitation guidance documents, and returned them with substantive comments to the Chemistry Expert Committee. LASEC and NELAP AC members were notified to suspend their review until the next iteration is available. The timeline is uncertain.

#### 4) Standards Review

There has been no feedback from the Lessons Learned document yet. The SIR Subcommittee did not meet in April.

The LASEC recommendation to adopt V1 and V2 of the 2016 TNI Standard was formally presented to the NELAP AC at its April 2 meeting. It is unclear what impact the needed revisions to the chemistry guidance will have on the Accreditation Council's timeline for adopting the standard and setting an implementation date.

#### 5) Conflict of Interest SOP 3-113

There was no quorum, so the planned approval vote for this document was postponed until the May meeting.

## 6) NELAP Decoupling Policy 3-102

This policy was approved by LASEC in March with a new section about interim oversight between triennial evaluations. Lynn provided a short list of suggested survey questions for the "interim oversight," as discussed by the NELAP evaluators, and asked for feedback. The questions will likely become an attachment to the NELAP Evaluation

SOP 3-102 at its next revision, where the interim oversight will be added to the process. Judy proposed adding one additional question, for ABs that have begun using third party assessors since the previous evaluation, does the AB believe it is in compliance with what is now §7.4 V2M1, Subcontracting the Assessment. NOTE: This section includes a "note" in ISO language that contracting of external individual assessors to the AB is not considered to be subcontracting.

## 7) Next Meeting

The next scheduled teleconference meeting will be Tuesday, May 22, 2018, at 1:30 pm Eastern time. A reminder with agenda will be sent prior to the meeting.
