Laboratory Accreditation System Executive Committee Meeting Minutes July 26, 2016 1:30 pm Eastern time

1) Welcome and Roll Call

Judy Morgan welcomed everyone to the meeting. Those in attendance are recorded in Attachment A. Minutes from the June 28 meeting were approved unanimously.

The email vote on the May 24 minutes brought two additional "yes" votes, which were adequate to complete approval of those minutes.

2) Assessment Forum and Mentor Session

In Barbara's absence, various individuals reported on the final status of the Mentor Session and Assessment Forums planned for the summer conference sessions. Each of the sessions is well and thoroughly planned, and the final session agendas were included in the June 28 minutes.

3) SIRs

The SIR Subcommittee reviewed six SIR responses from expert committees. These were some new submissions and a few older ones that for whatever reason had not yet been reviewed. Two will be returned to the committee for reconsideration or clarification, one was tabled for a future meeting, and the others will be posted to the NELAP AC's voting site.

4) Status of Standards Review

The recommendations to accept the remaining standards documents (PT/V1M1&V2M2, QS/V1M2, LOD/LOQ, Chemistry/V1M4, and Microbiology/V1M5) were delivered to the NELAP AC at its June 6 meeting. Some ABs had not completed their review of the documents by the AC's July 5 meeting, and the NELAP Chair indicated that she will plan to initiate an email vote at the AC session at conference, with votes to be cast after the expert committee sessions explaining the revised modules.

Judy noted that many of the reviewers of modules from the full Volume 1 have responded to her status request, and that while there are a few editorial items, no one is reporting show stoppers. She hopes to have a full set of summary reports no later than August 3, so that she can discuss them at the LASEC session at conference. She will send out a final reminder on Monday, August 1.

The final versions of all modules for Volume 1 of the 2016 TNI Standard were delivered to LASEC a few days before this meeting, and distributed to committee members. These modules have been through the Standards Review Council (SRC) and are ready for LASEC's final review and presumably our recommendation for adoption to the NELAP AC. See Attachment D for the explanation provided by the Consensus Standards Development Executive Committee Chair (CSDEC) about the SRC and its review.

Lynn noted several items about the new standard from the July Board meeting. First, a version of Volume 1 will be available for sale on the TNI website prior to conference, due to multiple requests for it. This volume will consist of the modules reviewed by the Standards Review Council (refer to June minutes for description of that review), with final formatting. A later version will be published (a decimal increase in revision number) with any final editorial revisions and the anticipated ANSI approval logo.

Second, the Board considered and consented to having the PT Program Executive Committee review and adopt Volumes 3 and 4. Volume 3 is for PT providers and Volume 4 is for PT provider accreditors, and the Accreditation Council had noted that since it has no responsibility for either of those functions, it didn't really make good sense to have the AC review and adopt them.

5) On-Site Assessment and Prep Method Policies for the NELAP AC

Judy addressed these two much-delayed policies. She has identified one committee member to undertake revisions of the on-site assessment policy, and another individual (not on the committee presently) to take over development of the prep method policy. Both drafts will be distributed by the end of July and the on-site assessment draft will likely be discussed at the committee session at conference.

Judy asked that review comments on the two draft policies be sent by email to all committee members, prior to conference.

The NELAP AC chose to update its Evaluation SOP 3-102 using a small subcommittee of AB representatives. The Council-approved version was distributed to LASEC members for review only, with the announcement for this teleconference meeting. Judy indicated that she is reviewing it in detail. Since Policy Committee review of this document is presently underway, any minor tweaks suggested by LASEC can be considered by the AC when making the Policy Committee's requested revisions. Comments on this SOP should be sent to Judy and Lynn within 2 weeks.

6) Attendance at Conference

Nearly everyone on the call plans to attend conference in August. The session will be on Monday, August 8, at 10:30 – noon, local time (Pacific Daylight) or 1:30 pm Eastern. A speakerphone will be available, so that committee members not attending conference may participate if they choose.

7) New Business

There was no new business. The meeting adjourned about 2:10 pm Eastern.

8) Next Meeting

LASEC will meet next on Monday August 8 at 10:30 am at conference. A speakerphone will be available, and the call-in number is 218-339-7800, passcode 155258#
