# Microbiology Expert Committee (MEC) Meeting Summary

## July 9, 2013

#### 1. Roll Call and Minutes:

Robin Cook, Chair, called the meeting to order at 1:30pm EST. Attendance is recorded in Attachment A – there were 5 members present. Associate Members present: Carl Kircher.

#### 2. Small Laboratory Handbook

The Quality Systems Expert Committee took on the responsibility to review the Handbook for adherence to the new standard. Our committee was asked to review the Microbiology information. The committee continued to review this document on screen and make changes directly into the document as changes were made. Robin will send this document out to the committee after the call for final review and discussion in San Antonio.

Sample Handling

Carl commented that it is important to make an addition to the handbook about noting which version of standard methods is used and referenced. There are differences in QC. Robin added this

Section 1.7.3.7. Question about checking temperatures of incubators. If the incubator is at the correct temp when you remove your samples, do you really need to check it every 4 hours? The standard does currently require it. Robin commented that these are the types of things the committee needs to look for as it begins updating the standard.

Carl also commented that this could have something to do with the EPA Drinking Water Manual, so they should be consulted before making any changes. It was confirmed that the DW manual does contain the same language, so changing this will take a lot of work. We could work with ELAB to get this changed.

#### Under Volumetric Equipment:

Equipment needs to be checked prior to first use, but how is criteria for check determined?

A statement was added as number 1 and the other listed items became 2, 3 and 4 - Tolerance on volumetric equipment must be established and documented.

<u>Lab glassware and plastic ware</u>: #6 – Why must this be tested?

Looked at DRAFT standard (Page 11 - Section 1.7.3.7 vi) <u>Labware and Glassware</u>. Nothing like #6 is included in the standard – so where did it come from? The committee determined that it should be stricken.

## 1.7.5 Sample Handling

Elizabeth suggested some changes that matched the standard language better (4 bullets) regarding chlorine checks. This is an option that prevents the need to check every sample.

Robin thinks the only thing that might be able to be deleted will be the section starting with: "Laboratories that receive samples from potable water sources ... may (use language from the 2003 standard).

Robin saved the document and will send it to committee members. She would like comments back by 7/19/13. She will ask Paul if it should be discussed during the Microbiology meeting or Quality Systems meeting in San Antonio.
