## NEFAP Executive Committee Meeting Summary August 10, 2017

## 1. Roll call:

Justin Brown, Committee Chair, called the NEFAP Executive Committee meeting to order on August 10, 2017 in Washington, DC at 10:30am Eastern. Attendance is included in Attachment A - there were 9 committee members present.

Meeting minutes will be reviewed at the next regularly scheduled teleconference.

#### 2. Overview

Justin reviewed the agenda for the meeting and then reviewed the history of NEFAP, accomplishments, information about the Strategic Planning Subcommittee and where the committee is today – Attachment D.

NEFAP is structurally sound, but interest is stagnant compared to other environmental areas. Growth is minimal. Advocacy efforts have slowed. Strategic Planning Group meetings have also slowed.

#### 3. What Do We Do Now ...

Justin went through the questions in Attachment D and discussion is recorded below.

- There is no mandate. Russell feels awareness is an issue. He only became aware of NEFAP in February by coming to a meeting.
- We don't have a budget to support outreach.
- Shannon asked what is being accepted to support EPA's initiative on sampling.
   Mike asked if it is being implemented he doesn't think it is being enforced.
   Marlene thinks that project officers are accepting competency based on historical work.
- Marlene said another avenue is opening up she thinks investigations on sampling activity will drive NEFAP. She thinks there is a movement happening at state and federal level to do this.

- Calista was at a meeting where she emphasized that something needs to be done about quality of sampling before the next Spill like the Gulf spill. NOAH. Tracy noted that they accredit a lab involved in this and they need to look to see if a lab has a sampling division and encourage them to become accredited.
- Kim Watson: No one is forcing the demonstration of capability on samplers.
- Russell's customers are not asking for it.
- Shannon noted that people don't know the NEFAP name. They know the ISO name. Is there a way to align more with ISO?
- Kim Watson: The NEFAP AB websites present NEFAP differently on their websites. One uses the term NEFAP and other's refer to it differently. Also need to look at how FSMOs are promoting it on their websites.
- Kirstin asked if cost is an issue of the accreditation. The actual accreditation is not the issue, but what it takes to become accredited is the issue.
- Bennett noted the actual fees for accreditation are the bigger issue.
- Some states have an issue with requiring two accreditation lab and field. Tracy noted that is not as a big a problem for NGABs. They can audit an organization for 17025 and combine it with a NEFAP accreditation. Shannon wonders how we break the barrier to states? Shannon said name is a problem and cost is a problem. Kim thinks labs jump on FSMO accreditation when it is coupled with other accreditations.
- Shawn noted that the states are seeing that sampling is important as they are working on cannabis. Sampling has been the biggest elephant in the room for many years. How does the accreditation make things better?
- Paul emphasized that the petition for rule making needs to add the changes needed. Less waste. Less duplicated effort benefits of NEFAP. Every state is different and each state needs to be approached separately.
- The clients of the engineering firms (DoD, etc) need to be convinced it is needed. Until that happens, engineering firms aren't going to want to pay more.
- Do we know stats of the website? We still need to finish updating the Website.
- When are people going to be burned by bad data? Shannon noted that they ran into 3 serious issues and that is why their state started emphasizing sampling. Maybe we need to check with others for examples.

Ilona pointed out that last meeting we talked about pulling fraud issues out of Jerry's presentation.

- Bennett thinks the mobile lab issue is an opportunity. When we look at mobile labs, is there a better way to provide both NELAP and NEFAP.
- Cheryl She thinks that we need to look at the final new ISO 17025. The new standard will support NEFAP or maybe sampling will be stand-alone. Tracy does not think that the sampling section under 17025 is as good as NEFAP. Kim wants a representative sample and ISO 17025 will not get her there.
- Jake (works with Russell) He doesn't care about the name. He's never seen an email. Ilona noted it is hard to build a good mailing list outside of TNI. Justin and Tracy worked off a paid mailing list and a majority of the emails bounced.
- Kirstin commented that ISO 17025 is a management practices standard. NEFAP is a best practices standard.
- Maybe NEFAP can look at the Ambassador Program Advocacy is doing with states and pick states, organizations or end users and do something similar.
- It was questioned whether NEFAP is using Social Media enough to reach out.
- A market strategy needs to be developed and then a budget can be determined. Shawn agreed to join the Strategic Planning Subcommittee.
- A public agency interested in FSMO accreditation commented that there isn't enough information or things of substance to sell the program to their management. A list of FSMOs would be help. Talking points on the value will be helpful.
- Shawn noted that sampling is a bigger deal in the new ISO 17025. He is concerned that there is not a marketing strategy. Where are the brochures? Marlene thinks that Advocacy is more aware of the need to support NEFAP.
- Be creative in raising funds to expand NEFAP. Sell T-Shirts at next meetings
