# Summary of the TNI NELAP Board Meeting November 2, 2009

#### 1. Roll call

The NELAP Board met at 12:30 PM CDT on November 2, 2009. Aaren Alger chaired the meeting. Those members in attendance are listed in Attachment 1. In addition to those indicated, Cathy Westerman, David Caldwell and Lynn Boysen also joined the call. Kevin Kubik joined the call as the recently appointed EPA liaison to the NELAP Board.

#### 2. Minutes

Minutes from the 10-19-09 meeting were approved for posting. Minutes for the 10-5-09 meeting were approved for posting with the added note under #4 Question 2 "The NELAP Board subsequently changed the implementation date for the new standards, and therefore there will be enough time to evaluate all experimental PTs before posting to the regular FoPT tables."

#### 3. Update on renewals and new applications

Lynn Bradley provided the following update on renewals:

IL – Response to the onsite report is due 11-6-09.

LADEQ –The evaluation team's review of the modified CAR is expected to be complete by the end of the week.

OR –CAR acceptable to the evaluation team. Recommendation to the NELAP Board for renewal expected by end of the week.

VA – Onsite evaluation and observation of mock lab assessment have been completed.

MN – Awaiting executive approval to submit application.

OK – Application in preparation. Estimated submission date summer 2010.

## 4. QAO Report

Paul Ellingson reviewed the new Attachment 5 to the QAO Report on AB evaluations. This table summarizes the findings in an easier to read summary format. There were no suggested changes to Table 5. Paul Ellingson indicated that he would make corrections that had been suggested earlier by Paul Bergeron and then add Table 5 to the report. The final report will then be forwarded to Aaren for distribution.

#### 5. Mutual Recognition

Steve Stubbs advised the Board that Alfredo Sotomayor had proposed a different approach for the mutual recognition policy. Steve will forward Alfredo's draft to the NELAP Board for consideration alongside the draft that had been prepared earlier by Steve Stubbs and Steve Arms. This item will remain on the agenda for the next meeting.

### 6. Approval of plan for experimental PTs

It was determined that no action was needed by the NELAP Board at this time. Eric Smith's previous email indicated that no response for the NELAP Board constitutes approval and the PT board is moving ahead with the plan for eliminating experimental PTs

# 7. Dispute resolution SOP

Brian Boling indicated that the subcommittee is focusing on dispute resolution between ABs. Several suggested that we need to have a process for resolving a dispute between a lab and an AB. Brian indicated that the SOP will allow the SOP to be used by a lab and an AB, but it is voluntary. It cannot be required because of state's due process requirements.
