## **Meeting Minutes**

The meeting minutes from the January Newport Beach, CA conference were approved.

### **Update on Technical Course Curriculum comments**

We received six comments about the course curriculum, four of them from the same person. I have left the draft on the website until the end of February at the request of Barbara Escobar to give her auditors group a chance to comment. When all comments are gathered, I'll forward and we can discuss them.

#### **Election of Committee Chair**

Election of the Committee Chair, per TNI policy, is to be done annually. Betsy Ziomek nominated Denise Rice and Don Cassano seconded the motion. The vote was unanimous that Ms. Rice remains the Chair of the Committee for another year.

#### **Decision Making Model**

Ms. Rice reviewed the different types of decision making rules in the TNI SOP. Ms. Rice provided several types of decisions that the committee routinely makes and the committee discussed what type of rule should be used to make the decision. Below is a table of the decisions and decision making rules.

There was a discussion about the rule to use for the approval of a standard. Ms. Ziomek felt that a unanimous vote was too difficult. If someone wanted to abstain they should be able to without halting the process. Mr. Gumpper felt that a standard should not move forward if the whole committee couldn't agree that it should go forward. Ms. Ziomek proposed using the Enthusiastic Support rule for approving standards with only a veto stopping the standard. The committee agreed this would be the best rule to use.
