2. SOP 6-101: SSAS Table Management

Sheri Heldstab (Chair, SSAS Expert Committee) was present to help with the review of this SOP.

Patsy eliminated the subsections in the Table of Contents because of consistency with other SOPs.

Section 1 - change "or" to "and".

Section 2 -

Paul will add the term Participant to the Glossary.

Section 3 -

Correct numbering and remove "current version". We are supposed to be using the current version of all documents.

Section 4 –

The Committee will circle back to this section when the SOP is completed, but it would like to recommend that the Note in the definition of Participant(s) be removed.

Section 5 -

A new Section 5.1.3 was added to make it clear that requests to change the Quality Systems Matrix will not be accepted. The rest of the sections need to be renumbered. This was added as a section and removed as a Note. TNI Volume 1 should be added as a reference or related document.

Section 5.1.4.2: add "in Committee minutes" so it is clear how the CRA is tracked.

New Section 5.1.6: Added the elements the SSAS table contains:

- 5.1.6.1 Matrix.
- 5.1.6.2 TNI Analyte Code.
- 5.1.6.3 Analyte.
- 5.1.6.4 Concentration Range.
- 5.1.6.5 Acceptance Criteria.
- 5.1.6.6 Audit Sample Reporting Limit (ASRL)
- 5.1.6.7 Toxicity equivalent factors (Dioxins and Furans only)

Section 5.1.5: Needs to be added above new Section 5.1.6 and add a new heading for section: Addition of Methods or Analytes, or Changes in Concentration Range for Existing Analytes. The section needs to be renumbered and sections referred to need to be corrected as needed.

Section 5.1.7.1: Change to: A Sponsor is required for the removal of a method, analyte, or group of analytes from the SSAS Table.

Sections 5.1.7.2 and 5.1.7.3: Correct numbering and capitalize Sponsor.

Section 5.2: Recommend that header read "Determination of Merit" instead of "Consideration of Requests" and change section placements and numbering.

Section 5.2.1: Recommend replacing "If a" with "When a".

Section 5.2.2: Recommend referring to "determination of merit" instead of "preliminary review".

New Section 5.2.3.1: Edit language to simplify and make clear.

Continue next meeting starting in Section 5.3. The agenda will be continued next week.
