- §6.7.1 should be reworded as noted in the June 21 minutes, to read "Observe all aspects
 of the NGAB's laboratory assessment, including but not limited to opening and closing
 meetings, interviews of laboratory staff, data review, quality systems review, etc."
- §5.1 is missing the text in place should be so numbered
- The page numbers in the Table of Contents should be checked for correctness in the cleaned up version
- §6.2.2.2 needs a font adjustment
- The correct application and checklist titles should be used in the definitions section.

With those corrections, Paul moved and Virginia seconded that the document be approved; the vote was unanimously in favor. The document will be submitted to the TNI Board for its review and approval in September.

3. Review and Approval of NELAP Dispute Resolution SOP 3-104

This document was given a five-year review by the NELAP Accreditation Council, with only minor changes.
