TNI Policy Committee Meeting Summary Friday July 18, 2014

1. Welcome, Roll Call and Announcements

The meeting was called to order by Alfredo at 11 am Eastern. Attendance is recorded in Attachment 1. Alfredo noted that any corrections to the minutes from June 20 should be submitted within the next week.

Alfredo also remarked that he received Patrick Blumfield's resignation from the committee. Pat stated that he no longer has time to uphold his responsibilities to this group. Committee members, please, consider who might be a valuable addition to this group as well as serving as liaison to one of the other TNI mission areas, and provide your suggestions to Alfredo before conference, if possible, but later if that's when you are able.

2. Guidance Proposal from Advocacy Committee

TNI's Advocacy Committee is updating the 1979 EPA "Handbook for Analytical QC in Water and Wastewater Labs" and realized that it may qualify as "guidance" so they submitted a proposal as required by the Guidance SOP. This proposal outlines the chapters and chapter editors as well as the justification for needing the update (it's 35 years old!) and planned reviewers of the final product.

One committee member suggested having the relevant expert committee review the individual chapters, but after discussion, all agreed that it would be adequate to have the expert committee chair(s) assign the review to one committee member. The purpose of this review will be to ensure that there is no conflict with the standard and that no new requirements would be imposed.

Committee members agreed that the project is a good endeavor, that it is indeed guidance, and that with the proviso that appropriate portions are reviewed by relevant expert committees (Quality Systems, Microbiology, and Field Activities.) John moved and JoAnn seconded approval of a motion to that effect, and approval was unanimous. Alfredo requested that Lynn transmit the approval to the Advocacy Chair and PA.

3. New Assignment from TNI Board

At its July 9 meeting, the Board requested that Policy Committee review the Bylaws and appropriate policies for potentially needed adaptations to address termination of membership for someone who fails to abide by TNI's documented expectations for professional behavior and ethics.

The Bylaws address removal of a member, and TNI Policies 1-102 and 1-107 plus the Guidance for Conduct of Committee Members address the expected behavior of TNI members. Jerry noted that TNI counsel has reviewed these documents and believes they are adequate for general purposes. Persons joining TNI online must agree to abide by these expectations, and Jerry will address how to obtain the same commitment from the few members who join through other mechanisms.

Because the underlying need for this review came from a comment submitted on a standard, the committee discussed whether CSD Executive Committee should address how inappropriate comments might be handled. Bob indicated that CSD EC is looking at SOPs 2-100 and 2-101 for this. Policy Committee also recommends that CSD EC develop a program policy addressing

acceptability of comments, as well, as the underpinning for the SOP adaptations. Bob thinks these may be ready for final discussion in DC if CSD decides to meet while there.

4. NGAB Evaluation SOP

Review of this document resumed at section 6.12, where it was decided there is no need to address a time delay before a rejected AB may resubmit its application for recognition.

§6.19 – the NGAB workgroup envisions that all potential evaluators will be trained before applications for recognition are invited, at least initially. Therefore any delay due to evaluator selection would be a "TNI delay" and not counted against the applicant AB. No change to existing text is needed.

At this point, time ran out. The NGAB Workgroup will meet in DC and discuss the revisions made per our June 20 meeting, and Policy Committee review will begin at the next meeting with §6.19.

5. Next Meeting

Policy Committee will meet again on Friday August 1, 2014, at 11 am Eastern. Teleconference information and an agenda will be circulated in advance of the meeting, to include the confirmation of a new Vice Chair for Policy Committee.
