Meeting Minutes October 27th, 2008

The Quality Systems Committee of The NELAC Institute (TNI) met on Monday October 27th, 2008 at 11:00 AM MST by conference call. The action items are listed in Appendix A and the attendees listed in Appendix B.

First Agenda Item: New Members

Six new members were chosen to be on this committee. The new members represent 2 Accreditation Bodies, 2 Others and 2 Accredited Laboratories. Resigning members are Bob Di Rienzo and Wilson Hershey. The balance on this committee stands at 5 ABs, 5 OTs, and 4 ALs. The balance is maintained and the committee now has 14 members pending executive review and approval by BOD.

Second Agenda Item: Miami Mentoring Session

Betsy Kent joined this call and helped the committee discuss the upcoming meeting in Miami. All committee members present will be available for this mentoring session on Thursday morning. Topics for discussion include the Quality Assurance Manual, Required documents/procedures, Calibration of support equipment vs. instrument calibration, and the new format of technical modules including changes to DOC. Betsy will forward notes with other topics by end of week and this committee will develop presentation materials for the mentoring session. Presentations will be a simple format with the sections of the standard, Discussion items by the committee and an open mike Q&A with the committee. Presentations drafts are due in early December.

New Business: The LASC complete their review of the TNI standards. The committee discussed LASC concerns and made recommendations. Bob shared notes with Paul and Paul will formulate the committee response. This document will be sent to the committee for concurrence prior to responding to the LASC. The committee may revisit this on the next conference call.
