

The NELAC Institute (TNI) Quality Systems Committee Meeting Minutes April 14, 2008

First Issue: Status of Standards

The Uniformity of Standards (UOS) committee has completed their review of the standards and Ken Jackson has edited what was considered editorial changes into the final standards. As was pointed out by Paul some of these editorial changes were comments submitted by this committee in September 07 and the committee had already review, discussed and determined the fate of these edits. The committee than reviewed the entire UOS report and in a report to Ken Jackson reversed some of the editorial changes that were already submitted. Bob and Paul will review this with the CSDB in the next meeting.

Second Issue: Implementation Guide

As determined by our previous conference call it was confirmed that the NELAC BOD would like us to work on the current NELAQC checklist. It was decided that each committee member will take a portion of the NELAC checklist and insert the TNI standard reference into the document using Module and Section numbers. Bob will edit the NELAC Checklist to add a column for the TNI reference and will make assignments for each committee member. Michelle asked to review Toxicology sections and Robin to review the micro sections. This process should take the next three meeting with problem areas (not clearly defined) to be discussed in conference calls.
