## The NELAC Institute (TNI) Quality Systems Committee Meeting Minutes January 22, 2007

The meeting will begin with a review of changes from comments received. We will start with the General Requirements Module and work through the technical modules until finished. The committee decided to use Thursday night in Denver for hearty refreshment and merriment.

The final discussion centered on how meeting minutes will be approved in the future. It was decided that minutes would be send for review, final edits will be made and approval will be done by email within two weeks of any conference call.

Bob will send out newly renumbered WDS to all committee members by the 1/25/07.
