  All present confirmed receipt of the documents e-mailed July 8, 2011.
- Review and approve minutes from teleconference on June 27, 2011
  A quorum was not present until late in the call. Therefore, Ken will request an e-mail vote on the draft minutes.
  - 3) Chair Update

Maria reported that Theresa Lowe has now been confirmed as a Committee Member. She suggested Theresa would not be able to vote on issues that were under discussion prior to her becoming a Committee Member. Although this rule was applied to other new members, it was questioned whether this is TNI or ANSI policy. Maria will check with Jane Wilson. It has been confirmed that Paul Meeter's application has been received by TNI, and when received by the Committee they will move it through the approval process.

Maria asked Shawn to give a brief update on the subcommittee's activities. He reported they met with Wayne Stollings and Charles Simon to discuss the questions posed by the Expert Committee. The subcommittee has developed a motion, and he will pass this on to the full committee if/when it has been voted on and approved.

The providers were asked if there was anything new on the accreditation process. Shawn said that ERA had queried A2LA and were preparing for the audit, but they have not heard anything yet about scheduling. Ty said that Wibby was in the same position as ERA; they had sent emails to A2LA requesting a formalized schedule, and had not yet received a response.

**Action Item** – Maria will ask TNI to announce the availability of the program to the other known providers.

Wayne expressed concern that a laboratory could cheat by directly injecting the audit sample instead of taking it through the analytical procedure. Shawn agreed, but said this is no different from a laboratory being able to cheat this way with some proficiency test (PT) samples. However, it is the job of the regulator to make sure this does not happen. Ken confirmed that NELAP on-site assessors examine the laboratory data for PTs, to confirm they have treated them in the same way as routine samples. He added that he never experienced laboratories trying to cheat in this way in the NY program, and Mike Miller confirmed that he only saw this attempted on 1-2 occasions in NJ.

## 4) Continue discussions re. SSAS Table

Maria presented a draft (redline/strikeout) version of the table with all the amendments agreed to date. She went through the footnotes of this table, and the only questions or comments were clarification issues.
